Grant competition to identify three community colleges to receive threeyear grants to implement Back to Work 50+ program

Community colleges located in the following states are eligible to apply: Alabama, Arizona, California, Florida, Georgia, Illinois, Mississippi, New Mexico, New York, North Carolina, South Carolina, Tennessee and Texas.
